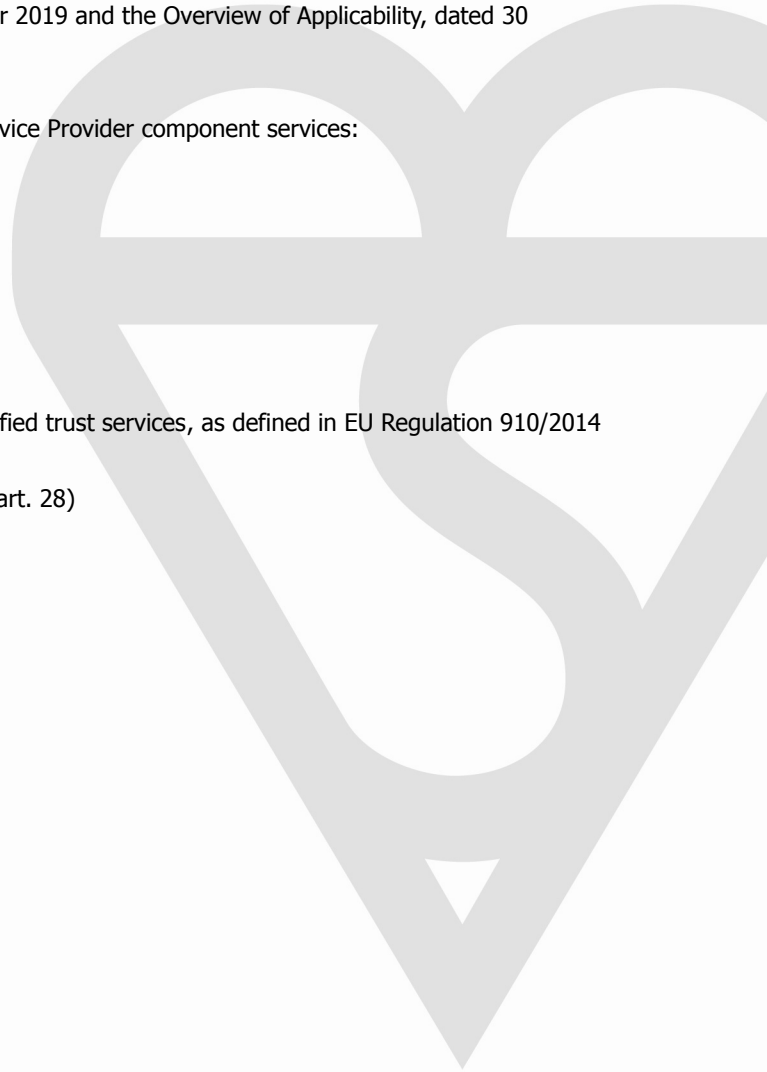

Information on Mozilla Bug 1539307 "Bypass: Insufficient Serial Number Entropy"

We assessed the follow-up of Mozilla Bug 1539307 and noted that Bypass implemented the corrective actions as mentioned in the bug. The two intermediate CA-certificates were revoked on 27 June 2019.
